

Call of the Election of the Candidate to Be Nominated as the Rector of Tomas Bata University in Zlín

**The Academic Senate of Tomas Bata University in Zlín
called the election of the candidate to be nominated as the TBU Rector,
and that at its meeting held on 5 June 2018.**

The election will be held in compliance with the valid Election Rules for the election of the candidate to be nominated as the Rector (Appendix No. 2 to the TBU AS Election Rules).

Instructions for the submission of nominations (Article 3 of the Election Rules for the election of the candidate to be appointed as the Rector):

- 1) The following persons can nominate candidates to be appointed as the Rector:
 - a) All members of the TBU academic community
 - b) All members of the TBU Board of Governors

The nominators can nominate more than one candidate.

- 2) The nominators are required to submit their nominations in writing on the nomination form to the Chairman of the Election Commission in a sealed envelope marked NÁVRH REKTOR, and that to the address given below:

The nominations must include the following information:

- a) Name and surname of the candidate including academic degrees, age, current post and employer of the nominated candidate
 - b) Consent of the candidate to his/her candidacy
 - c) Name, surname and signature of the nominator
 - d) Date of submission of the nomination
- 3) The nomination form is available in printed form at the Information Desk of the U13 building, nám TGM 5555, Zlín, and also in electronic form on the TBU Official notice board – link “Election of the Candidate to Be Nominated as the Rector”

Deadlines:

The nominations of candidates to be appointed as the TBU Rector must be submitted and delivered to the Chairman of the Election Commission **before 10:00** on Monday, **8 October 2018**.

The Election Committee will draw up a list of candidates from the nominations received that are in accordance with the requirements as set in Paragraphs 1 and 2 of the Instructions for the Submission of Nominations. The list of candidates will be published on the TBU official notice board at **12:00 on 8 October 2018**.

The meeting of the TBU academic community, at which all candidates included in the list will present their election programmes and reply to the questions posed by the present members of the TBU academic community, will take place in the **Assembly Hall (Academia Centre, U2 building, Mostní Street 5139 in Zlín) at 13:00 on Thursday, 11 October 2018**.

Before the beginning of the meeting, all candidates born before 1 December 1971 or 1 December 1971 must submit to the Chairman of the Election Commission a certified copy of the Certificate issued in compliance with § 9 Paragraph 1 of the Law No. 451/1991 Coll., which specifies other qualifications for selected posts in state authorities and institutions in the Czech and Slovak Federal Republic, Czech Republic and Slovak Republic (“lustration certificate”) and a signed declaration of honour in compliance with § 4 Paragraph 3 of the Law No. 451/1991 Coll. The election of the new Rector will be held at a regular session of the TBU Academic Senate, to take place on Tuesday, **16 October 2018**.
