PART ONE INTRODUCTORY PROVISIONS

This Annex shall amend Rector's Directive No. 20/2020 – Rules of Student Grant Competition Held at Tomas Bata University in Zlín.

PART TWO SPECIFICATION OF ALTERATION

a) In Article 4 Grant applications, assessment and approval thereof, Paragraph 2 Letter fe) shall be altered and shall read as follows:

Additional expenses

Additional (overhead) costs (e.g. administrative costs, expenses for energy use and services); the mentioned costs must not exceed 20% of the total non-investment costs of the project.

b) In Article 5 Changes during the project implementation stage, Paragraph 2 shall be altered and shall read as follows:

Changes during the project implementation stage can be applied for by the Project Investigator or by the guarantor. Applications for changes can be submitted to the Evaluation Commission of the relevant organizational unit, which shall forward the application together with the Commission's opinion to the IGA Board. The IGA Board shall forward the application together with the Board's opinion to the Rector, in the following cases no later than 30 September of the relevant calendar year. With regard to the outbreak of the COVID-19 disease and related

measures, the above-mentioned deadline shall be extended to 30 November 2020 for projects implemented in 2020. The following changes are being referred to above:

- a) Premature termination of the implementation
- b) Change in the total amount of personnel costs/scholarships
- c) Major change in the project's funding structure, namely in other types of expenses (exceeding 20% of the total project budget approved for the given year of implementation)
- d) Change in the total amount of project costs exceeding 5 % of the resources provided
- e) Return of financial resources
- f) Change in the person of the Project Investigator or of the guarantor
- g) Gross infringement of the Rector's Directive 'Rules of Student Grant Competition Held at TBU' in the valid version

Other types of changes, that are not required to be applied for, must be duly substantiated in the interim/final report.

Other provisions of the Rector's Directive No. 20/2020 shall remain unchanged.
