Article 1 Introductory provisions

- (1) This Rector's Directive regulates, in compliance with the Rules Governing Habilitation Procedures, Professorial Appointment Procedures and Procedures for Appointment of Adjunct Professors at Tomas Bata University in Zlín:
- a) the fees for actions related to a habilitation procedure,
 - b) the fees for actions related to a professorial appointment procedure
- at Tomas Bata University in Zlín (hereinafter referred to as "TBU").

Article 2 Fee for actions related to a habilitation procedure

- (1) The amount of the fee for actions related to a habilitation procedure has been set for the 2023/2024 academic year as follows:

Article 4
Payment of the fee for actions related to a habilitation procedure

- (1) The fee for actions related to a habilitation procedure is non-refundable; it is a TBU income, and shall be allocated to the Faculty at which the habilitation procedure has been commenced.

Article 5
Payment of the fee for actions related to a professorial appointment procedure

- (1) The fee for actions related to a professorial appointment procedure is non-refundable; it is a TBU income. The fee for actions related to a professorial appointment procedure

shall be distributed equally between TBU and the Faculty at which the professorial appointment procedure has been commenced.

- (2) The transfer of the fee for actions related to a professorial appointment procedure from TBU and the distribution among Work Breakdown Structure components of centralized TBU resources and the relevant Faculty takes place directly in the bank depending on the variable code.

Article 6
Final provisions

- (1) This Rector's Directive amends the Rules Governing Habilitation Procedures, Professorial Appointment Procedures and Procedures for Appointment of Adjunct Professors at Tomas Bata University in Zlín, and, at the same time, abrogates the Rector's Directive No. 14/2022.
